Clearfell Harvesting Report – Oak Bridge – November 2021

Summary

- Gross revenue for the month is **\$471,765.65**
- Costs for the month are **\$445,724.75**
- Net income for the month is **\$26,040.90**
- Tonnes harvested for the month is **3,884.61**
- Net income per tonne for the month is **\$6.70**
- Area cleared for the month is **8.6** hectares

The project performance to date is set out below:

- Project gross revenue to date is **\$11,489,976.04**
- Project costs to date are **\$8,147,820.49**
- Project net income to date is **\$3,342,155.55**
- Tonnes harvested to date is **81,751.85**
- Net income per tonne to date is **\$40.88**
- Recoverable volume per hectare to date is **772** tonnes
- Net income per hectare to date is **\$31,559.54**
- Total forest area is **193.8** hectares, approximate hectares cleared to date is **105.90** hectares.

The total forest area reflects all net stocked areas regardless of age class or previous roadline volumes.

NB: Measured harvest areas are estimated monthly and reconciled with satellite imagery prior to valuations, they are subject to change and should be used as a guide only.

Revenue

Log Sales

Gross income for the month was **\$471,765.65** with an average sale price over all grades of **\$121.44** per tonne.

November 2021 - Log Markets, Hawkes Bay

The November export prices have dropped \$13.86/Jas m³ on average. The decrease has affected the pruned grades slightly more.

Radiata log inventories on the main Chinese ports we monitor have decreased to 4.60Mm³, with daily offtake relatively solid at 73Km³ per day as we head into the Northern Hemisphere's winter. Inventory remains 40% above 2018-2020 levels and this is creating downward pressure on CFR sales price.

As mentioned last month, there has been a structural reset in the Chinese economy with the government looking to slow the property market and reduce debt levels. As is often the case, many believe the market has overcorrected. Several factors have contributed to weaker log demand / usage however, the major reasons are adjustments to the construction market due to high debt ratios of property development companies and the energy crisis limiting factory output. China's zero-tolerance policy towards Covid-19 continues to have impacts as workers in new outbreak regions get sent home to control the spread of the virus.

The freight market has continued to trend downward however, at this stage the Chinese appear to be taking advantage of freight cost gains by lowering the CFR price. Due to the lag time of ship chartering, we expect to see pre-booked vessels in December also affecting AWG prices.

The NZD has continued to slip back against the USD since the end of October. The change has not been enough to add some AWG value for forest owners.

Domestic pruned log prices have fallen \$15 this quarter due to weaker AWG export pricing and factoring in the spring effects on Jas conversions.

Grade Recovery

Grade out turn for November is as follows:

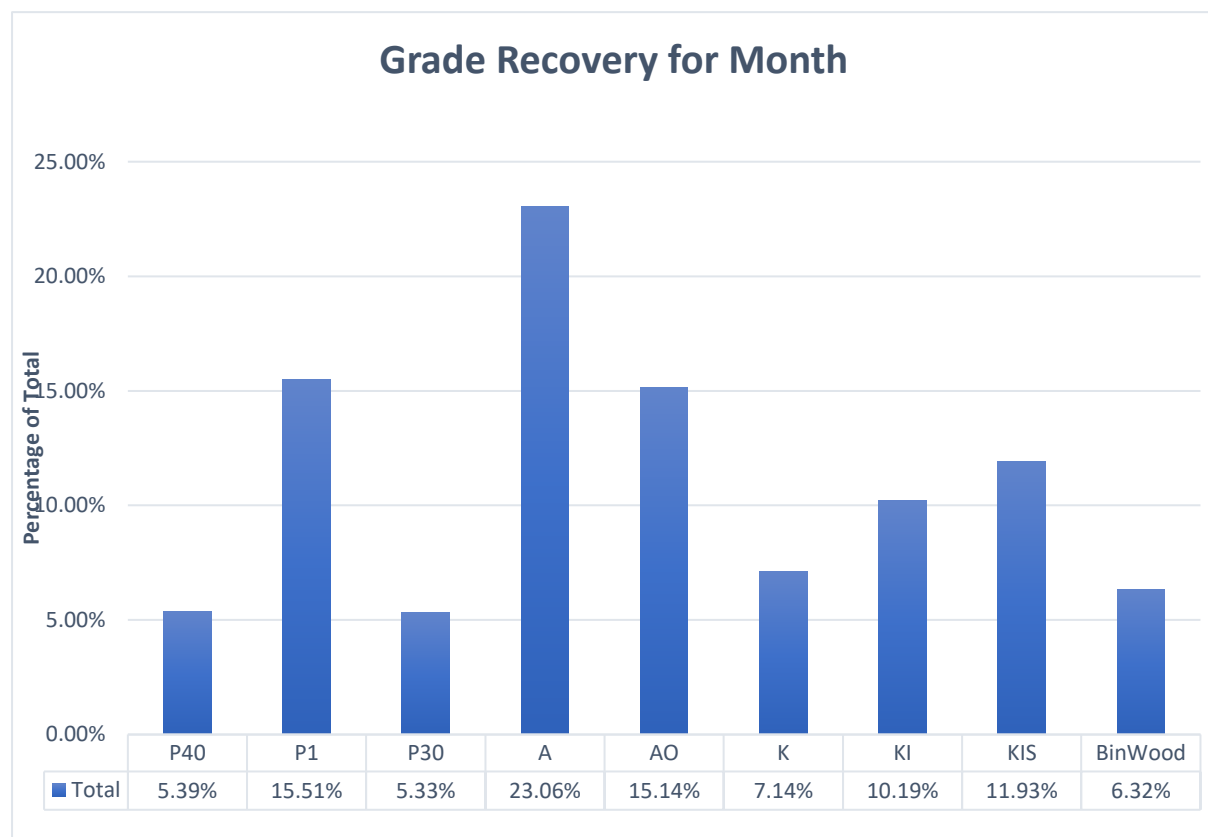


Chart 1: Grade Recovery for Month

Pruned recovery for November comprised 26% of overall sales volume, 16% of which was sold as domestic pruned grades.

High quality export sawlog (AO, A and K grades) made up 46% of the total production volume, with lower quality export (KI and KIS grades) comprising 22% of volume.

The remaining 6% of production was made up of domestic pulp and binwood.

Expenditure

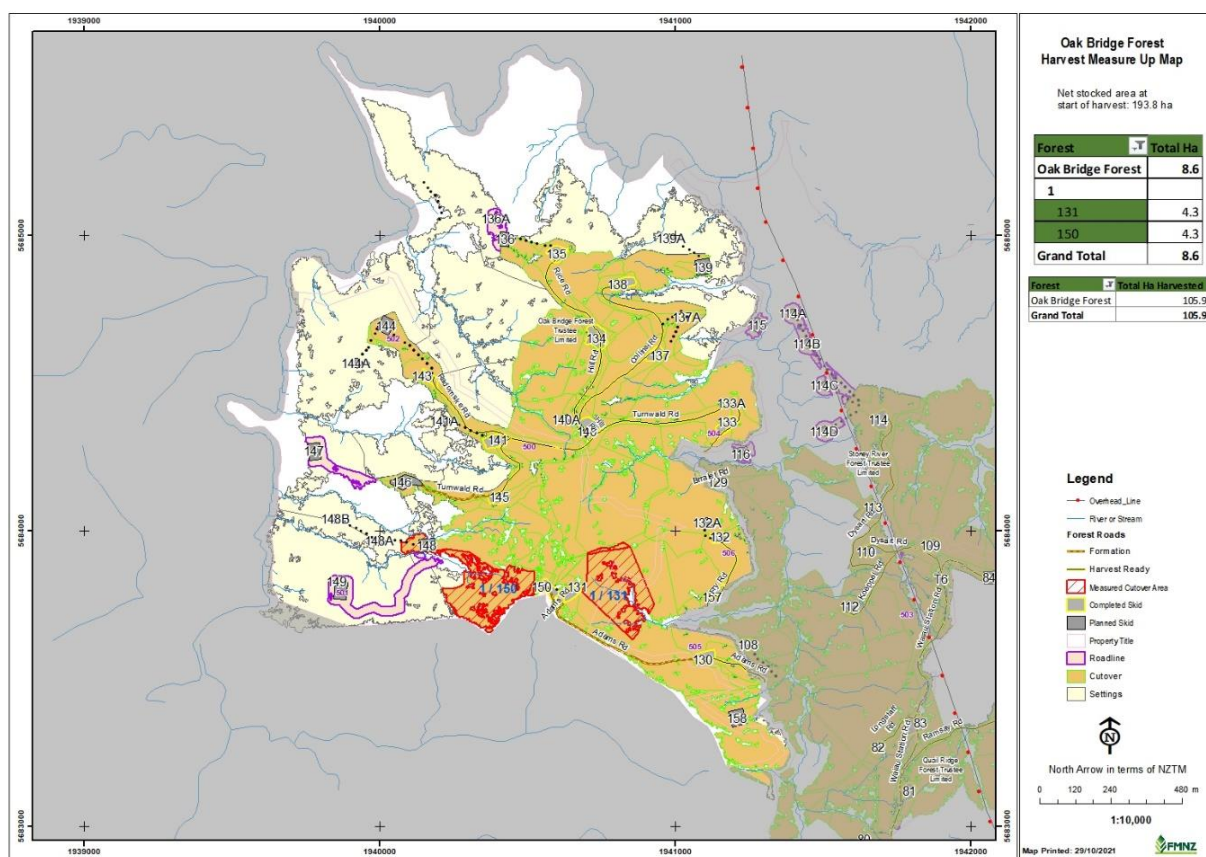
Harvesting

The total logging cost for the month was **\$164,445.78**, an average of **\$42.33** per tonne.

During November the harvest crew completed harvest of Setting 131 and then moved to Setting 150, Adams Road. There was some really big wood in this setting and apart from a small machinery breakdown, pulling went well. At the end of November, the crew moved to a small clearfell section on Landing 48 on Snowdon Road.

Cartage

Cartage is managed by Harvest Logistics Ltd, who organise the despatch and supply of log trucks into the forest.

The total cartage expense for the month was **\$127,191.05** which is an average unit rate of **\$32.74** per tonne.

The average cart rate for November inclusive of weighbridge and trailer lifting fees is **\$33.06** per tonne.

Trailer lifting costs are for use of the public gantry to reload trailers for loads delivered outside the normal hours of the facility provided by the Napier Port.

Earthworks was completed on Adams, Radomske, Snowden and Turnwald Roads during November. This is in order to set up ahead of the clearfell crew as far as Landings 144, 148 and 146.

Planned Activities for November 2021

Planned activities for December are for the harvest crew to ground-base harvest a corridor off Setting 148.

December earthworks will concentrate on finishing off what has been opened up, metalling and stabilising all sites before the extended Christmas break.

The orange cumulative line measures actual performance against the forecast budget.

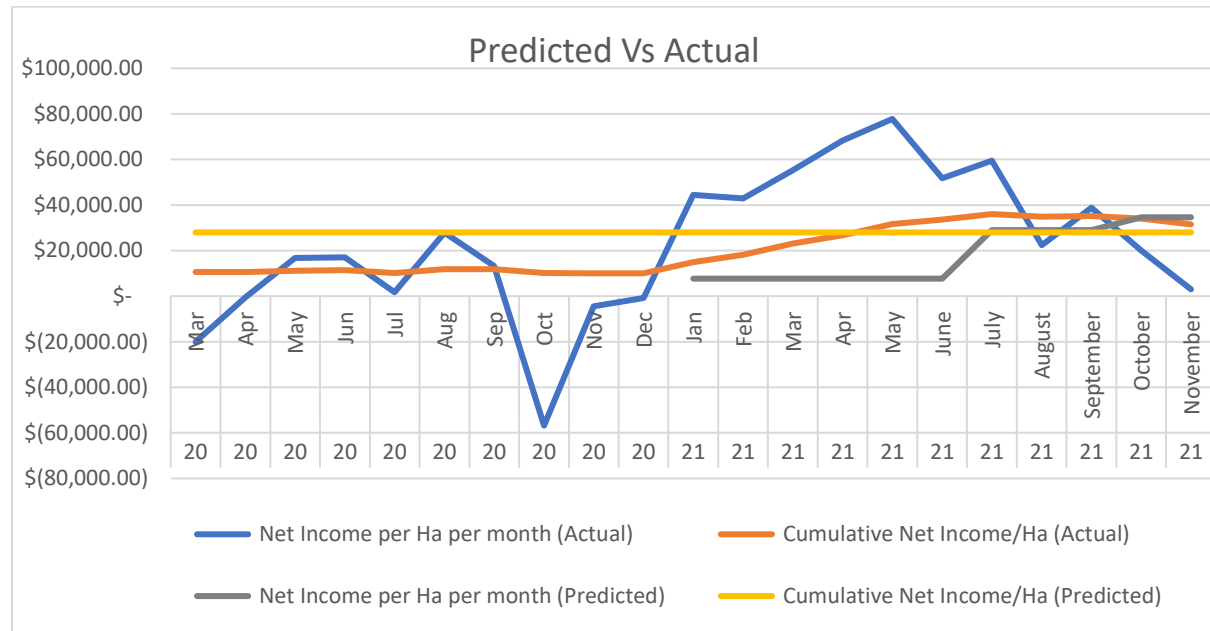


Chart 2: Actual vs Predicted
